Thank you for your recent email expressing your concerns regarding the construction of the Greenfield South energy project in the City of Mississauga.

As you may be aware, this site underwent an Environmental Assessment and was granted a certificate of approval in 2008. Strengthened by the feedback from the community consultation at the time, the plant will be required to meet stringent safety and environmental requirements that include; ambient air monitoring for two years and stack emission monitoring to assess any off-site impacts. As well, a community advisory committee will be established to work together to monitor activities and share information.

For many years, I have been active, along with other residents in Etobicoke-Lakeshore to ensure that we have "Good Air, Safe Power". The GASP Group worked in support of the demolition of Lakeview Generating Station in 2005.

As MPP for Etobicoke-Lakeshore and a resident of this community, I have always been concerned about air quality and quality of life in Etobicoke-Lakeshore and can appreciate that both our community and surrounding areas have questions about the possible impact on local air quality and the environment.

Although consultations were part of the Environmental Assessment process, there have not been any consultations in several years, during which time many new residents have moved into Etobicoke-Lakeshore. As such, I have asked that the Minister of the Environment and the Minister of Energy conduct a review of environmental impacts. If the results indicate that the air quality or environment in this community will be compromised by the construction of the Greenfield South power plant, you can be assured that I will not support its construction.

Working to find a solution to our community needs, as well as the province's plans to replace our energy supply with new, clean reliable sources of energy must be balanced with the need to address potential environmental impacts. Thank you for your e-mail of June 19, 2011 bringing to the Minister's attention your concerns about the construction of the Greenfield South gas-fired generating station in south Mississauga. I am pleased to respond on behalf of the Minister.

You indicated your concern about the issuance of a construction permit for this facility. Please be aware that it is the responsibility of our municipal partner, the City of Mississauga, to issue construction permits and to determine appropriate land uses according to municipal zoning requirements. The Ministry of the Environment encourages municipalities to consider our D-Series Guidelines to establish separation distances between incompatible land uses when preparing official plans and making zoning decisions. I would encourage you to contact the City of Mississauga about your concerns with this project.

The proponent in this case, Eastern Power, fulfilled the technical and regulatory requirements of the Environmental Screening Process to the satisfaction of the Minister by preparing comprehensive scientific studies and consulting with the public. Approval to proceed with this undertaking was given by the Minister in July 2008. A Certificate of Approval (Air) was issued by the ministry in December 2008, after a detailed technical review of the project confirmed that the facility could meet our stringent emission standards. The Certificate of Approval (Air) imposed conditions on the facility requiring it to be operated to meet provincial emission standards and in an environmentally responsible way.

Nevertheless, the ministry is aware of the concerns raised by you and other local residents. We are also aware that some land uses have changed in the area, for example, people are living in buildings that are taller than what was present previously. This is why the ministry has decided to review the Certificate of Approval (Air) for the Greenfield South plant to ensure that the plant can be operated in a way that is fully protective of the public health and the environment. We will notify you of the results once the review has been completed.

The emissions from the plant know no boundaries and the broader community has a right to know what's happening with the proposal and what the province is doing to halt it.

I am extremely concerned with hearing that the City of Mississauga issued a building to clear the way for Eastern Power Ltd to build a 280-megawatt gas-fired plant in the southwest of Mississagua just west of the Sherway Gardens mall.

As I am sure you are aware, the site backs onto the Etobicoke Creek, a hospital, residential areas, and new condomimiums that were not taken into consideration in the initial approval of the project.

The emissions from the plant area expected to pose air pollution and human health and safety risks. The plume that could come out of the Greenfield South plant, which is the escaping particulate matter that's carcinogenic

and unhealthy, blows east and southeast, affecting all of the residents in the Long Branch, Mimico, Lakeshore, West Toronto and downtown Toronto areas.

I understand that the Minister of Energy pulled the plug on the Oakville plant in October 2010, citing that "changes in demand and supply" as well as successful conservation efforts meant the Oakville plant was no longer necessary for the Southern GTA's energy needs. With this confirmation from the province that the need for the energy is no longer an issue for the area, why would the similar Greenfield South project still go ahead?

I greatly appreciate that Minister John Wilkinson has decided to review the MOE's decision to approve plans for the plant. I understand that MOE issued a certificate of approval in 2008, but with the changes in the provincial energy picture and the surrounding land use changes, the project is being called into question. The initial approvals were granted when local, gas-fired powered generation was seen to be the right solution, but seemingly the picture has changed given the recent decision in Oakville. I think it's important for residents to know whether this is the right source of energy, if needed at all, and whether our airshed in the western and downtown portions of Toronto is any less sensitive than that in Oakville.

With the cancellation of the Oakville plant, with work still being done on developing Ontario's long-term energy plan, and given the lack of information relating to the environmental assessment process demonstrating the impact of this project, this plant should not be built with so many unanswered questions as to its safety or necessity.

Simply stated, the natural-gas-fired power station is too close to residential and environmental areas and just like the Oakville plant, needs to be axed by Premier Dalton McGuinty. There is simply no need for the additional energy capacity and the unknown health and environmental risks are far too great.

As a resident of South Etobicoke, I am seeking ample proof as to why, months after the province cancelled a gas-fired power plant planned for Oakville, we are potentially going to be still stuck with a similar project our backyard. The plant seems unnecessary and potentially dangerous to public health and safety.

Please let me know what is being done to halt this project.

Natural Gas Plants

ISSUE:

Why is the government moving ahead with gas-fired generation in communities where it isn't welcome?

SUGGESTED RESPONSE:

- These plants are needed to meet increasing local demand.
- New gas-fired generation facilities such as Goreway Station, Halton Hills, the Portlands Energy Centre, St. Clair Energy Centre and York Energy Centre will meet the need for new, clean, reliable power in areas of rapid growth.

- The review will take as long as the ministry needs to confirm that the project can proceed in a manner that is fully protective of public health and the environment.
- The Greenfield South Power Plant is part of the overall plan to replace coal-fired generation by the end
 of 2014, and is required to be able to meet needs for local and regional reliability for the Southwest and
 Western GTA.

Oakville Generating Station:

- As we developed the Long-Term Energy Plan, it became clear we no longer needed this plant in Oakville. With transmission investments we can keep the lights on and still shut down all dirty coal-fired generation.
- We are discussing the effect of that determination with TransCanada.

BACKGROUND:

- Natural gas is widely used for electricity generation worldwide. Benefits of natural gas electricity
 generation include the ability to quickly construct facilities in strategic locations to relieve transmission
 bottlenecks as well as the ability of generators to provide load following and peaking service during
 periods of high demand.
- Furthermore, compared to the average air emissions from coal-fired generation, natural gas produces half the CO₂ (carbon dioxide), less than a third of the nitrogen oxides (NO_x), and only 1% of the sulphur oxides at the power plant.
- New gas-fired generation facilities in Ontario perform two major roles within the electricity system: they
 address local reliability requirements (for example, the Portlands Energy Centre in Toronto's east end,
 and Goreway Station in Brampton); and they support the government's commitment to replace coalfired generation (for example, the Greenfield Energy Centre and the St. Clair Power facility which are
 both located in the Sarnia area).
- The Ministry of Energy and the Ontario Power Authority have undertaken several procurements to contract for new gas-fired supply.

Greenfield South

Greenfield South Generating Station is a 280 MW combined cycle natural gas plant located in the City of Mississauga on a 4.5 hectare property at 2315 Loreland Avenue. Part of the project's property will be dedicated to the City as greenbelt, and the plant will occupy roughly 2 hectares of the property.

Eastern Power Ltd. is an equity contributor to Greenfield South Power Corporation, and is responsible for the project's design, engineering, and management, and provides operations and maintenance support. No information is available on any other partners.

The plant is 200 metres from the nearest residence, 700 metres from the nearest hospital and 1.1 km from the nearest school.

In XXXX, the plant was selected in the Ministry of Energy Clean Energy Supply competition and holds a contract with the OPA.

The Ontario Municipal Board reviewed municipal planning and zoning in 2007 and determined that the site was properly zoned and suitable for this type of electricity generation facility.

The project obtained environmental approval in 2008 from the Ministry of the Environment.

The City of Mississauga issued a building permit on May 31, 2011 for the building that will house the generation equipment.

The contract between Greenfield South and the Ontario Power Authority was renegotiated as a result of approvals delays, to extend the operational date. As of March 18, 2011, the OPA and Greenfield South have agreed to a new COD: Q3 2014.

Greenfield intends to proceed with the project and has previously indicated that they would pursue litigation if the City or the province moved to prevent the plant from being built.

Delays in the COD will exacerbate supply problems in the southwest GTA.

As a resident of Mississauga who also grew up in the neighbourhood just a few hundred metres north of the Greenfield South Power Plant site, I, along with many, many residents and business personnel in both Mississauga and Etobicoke, am immensely concerned and intensely opposed to the construction of this power plant on the chosen site! The site for this plant, as you are aware, is located in a densely populated area in extremely close proximity to residential neighbourhoods, condominiums, businesses, schools, Trillium Health Centre, a major shopping mall, Etobicoke Creek, etc. I query: Has the Minister ever physically visited the site? The emissions from this plant will compromise the health and threaten the safety of the citizens and natural environments in Mississauga, Etobicoke, and Toronto!

I have been in contact with the City of Mississauga and was informed that this matter must be addressed and stopped at the provincial level given the OMB's decision in the case of Greenfield South vs. Mississauga which

ordered the City to issue a building permit to Greenfield. Also, as Resolved at a June Council meeting, the City of Mississauga has requested a Full Environmental Assessment to be conducted on the Greenfield South proposal taking into account the cumulative impacts of all emissions on the Etobicoke Lakeview airshed. Could you also kindly provide the status of this request? At the same meeting, the City of Mississauga also resolved to request that the Minister of Energy conduct a full review to determine the necessity of this power plant in a densely populated area as opposed to the Nanticoke alternative where there is a three kilometre buffer zone. Please also provide the status of this request. Given that the Ontario government cancelled the Oakville power plant project stating that the power capacity from this plant was no longer needed, the question remains: Why is the Greenfield South power plant needed?

It is my understanding that the Greenfield South Power Plant can only be cancelled by the Premier and Cabinet at this point. I trust that the health and welfare of the citizens and the natural environment will indisputably take precedence over lower project costs, and that as our elected government official you, along with the Premier and Cabinet, will cancel the Greenfield South Power Plant without further delay.

Perhaps the Premier could apologize to the Mayor of Mississauga for the need to renege on his promise to <u>not</u> use the Lakeview site for power generation again. Pull back all the SW-GTA gas plants that are on the drawing boards, and announce they are all going to the Lakeview site.

I'm assuming OPG, and the Province, still owns the site. There could be contract change costs with proponents, but no reason why multiple owners-operators cannot co-exist on one integrated site – this is a new norm in the US.

Easy answer to NIMBY concerns that are slowing down the arrival of the generation that is needed to phase out of coal. Existing site is next to waterfront trail and a yacht club and a sewage treatment plant, rest of neighbours are mostly small industry.

Plus all the wires already go-come from there, easy add-on for the electricity system... since nothing is added on. The original capacity of Lakeview was 2400 MW, and it operated for ~10 years at 1200 MW capacity – so the wires/local system have the capacity for ~2000 MW+

Dear Mrs. Gabon:

Thank you for your email requesting information on the subject of conversion of Nanticoke Generating Station units to fire on natural gas.

Councilor Tovey is correct in that Ontario Power Generation is examining the feasibility of converting two units at Nanticoke to fire on natural gas. The possibility of conversion for system reliability purposes was identified in Ontario's Long Term Energy Plan. No decision has been made to proceed with conversion at this time.

Your information is also correct in that conversion of Nanticoke to natural gas has been previously studied and rejected. Electricity system planning is a continuous process and plans change with time as technologies advance and availability and costs of various forms of generation change.

Natural gas is now available at a much lower cost and future availability is projected to be much greater than before, making conversion somewhat more economical that the previous study indicated.

Having said this, conversion is still a relatively expensive option for other than peak generation purposes, and converted coal units are much less efficient and produce higher emissions than the combined cycle generating stations

The Councilor is not correct in asserting that converting the Nanticoke units is a solution for producing power for the South West GTA. If converted, Nanticoke GS would be run as a peaking plant, to stabilize power in its region of the grid, while minimizing the cost and impacts of the generation. In comparison to the combined cycle generating stations located within the SWGTA, Nanticoke would be too costly and have too high an impact on the environment to run to the extent needed to provide reliable power to the SWGTA.

I trust you will find this information helpful, and thank you for writing.





Hello Ceiran;

Regarding your SWGTA question related to Greenfield south.

Our studies show that the need date without Greenfield South is 2017. Therefore even without this local generator, there is no need to start a joint study with utilities in the area before the beginning of next year.

Also, as I mentioned we are investigating a possible reconnection of Horner TS from the Manby West 230 kV supply to the Manby East 230 kV supply. This is minor line termination work, performed immediately north of the Manby station, on the right of way. No residential or commercial buildings anywhere near-by. This minor work is expected to stretch this need date even further into the future and could have some near term operational benefits, such as minimizing operator actions during contingencies and increasing load transfer capability from Leaside to Manby.

Your email concerning the Greenfield South Generating Station has been forwarded to me for response.

Please understand that the Government of Ontario has set health, safety and environmental protection for individuals and communities as top priorities in the development of Ontario's electrical system.

The Greenfield South plant is replacing generation from the Lakeview coal plant and other coal plants which had a much higher health and environmental impact on your neighbourhood than the new gas plant.

The need for reliable supply to your community remains, and the combined cycle gas generation technology to be used at Greenfield South is the cleanest form of reliable generation available. The impact of the plant operation will be much less than other neighbourhood sources such as furnaces, vehicles, barbeques and yard equipment.

With respect to your concern about the environmental review process, Greenfield South's environmental report was subjected to a rigorous public and Ministry of the Environment review. Before any approvals were issued significant design and operational improvements were made to reduce environmental impact further.

While normally companies are only required to meet the standards and conditions that were applicable at the time the approvals were issued, the Ministry of the Environment is taking the unusual step to review the environmental impact of Greenfield South again to ensure that the plant meets or betters the current standards and conditions.

Gas and other fuelled generation facilities are commonly located and have operated safely within communities around the world, some large plants less than 200 meters from residences and other occupied buildings. Gas generation facilities at smaller scales are often attached to hospitals, to provide uninterruptible power.

Ontario's gas safety standards are very high and gas generating facilities are built and operated to the highest standards, so that they have proven to be of very low risk. I understand that you will continue to have concerns about Greenfield South; this is common in many communities when generating facilities have been introduced. This happened, for example, when Toronto's Portlands Energy Centre, a 550 MW gas generating plant, was being planned and built. Portlands has now operated for several years without complaint or concern expressed by the local community, and it has become a destination for plant tours by the public.

I trust you will find this information helpful, and thank you for writing.







Greenfield South

- Greenfield South is located in Mississauga. It is in the early stages of construction and major equipment has been ordered.
- The project's approval was delayed due to City of Mississauga opposition at the Environmental Approval and building permitting stages. As a result, the facility's contract was renegotiated to extend the operational date to the third quarter of 2014.
- The Ontario Municipal Board reviewed municipal planning and zoning in 2007 and determined that the site was properly zoned and suitable for this type of electricity generation facility.

Dear Mrs. Gabon:

Thank you for your email requesting information on the subject of conversion of Nanticoke Generating Station units to fire on natural gas.

Councilor Tovey is correct in that Ontario Power Generation is examining the feasibility of converting two units at Nanticoke to fire on natural gas. The possibility of conversion for system reliability purposes was identified in Ontario's Long Term Energy Plan. No decision has been made to proceed with conversion at this time.

Your information is also correct in that conversion of Nanticoke to natural gas has been previously studied and rejected. Electricity system planning is a continuous process and plans change with time as technologies advance and availability and costs of various forms of generation change.

Natural gas is now available at a much lower cost and future availability is projected to be much greater than before, making conversion somewhat more economical that the previous study indicated.

Having said this, conversion is still a relatively expensive option for other than peak generation purposes, and converted coal units are much less efficient and produce higher emissions than the combined cycle generating stations

The Councilor is not correct in asserting that converting the Nanticoke units is a solution for producing power for the South West GTA. If converted, Nanticoke GS would be run as a peaking plant, to stabilize power in its region of the grid, while minimizing the cost and impacts of the generation. In comparison to the combined cycle generating stations located within the SWGTA, Nanticoke would be too costly and have too high an impact on the

Overview

- This briefing will present the status of natural gas generating facilities that have been procured and are under contract to the OPA.
- Natural gas-fired generation has a relatively low cost compared to most other sources of new generation. The large natural gas generation facilities can be dispatched to provide power when it is needed. Natural gas is helping to replace coal-fired generation and integrate intermittent renewable generation leading to lower carbon emissions from Ontario's electricity mix
- Through various Ministerial directions, the OPA has procured 5,277 megawatts (MW) of new natural
 gas-fired generation capacity of which 4,154 MW is already operating. The OPA has indicated a need to
 procure one additional new plant of approximately 450 MW in the Kitchener-Waterloo-Cambridge
 area.
- Four plants located in the GTA have been the subject of strong local municipal and public opposition.
 Portlands Energy Centre in Toronto has been built and operating for several years and is no longer contentious.
- There have been calls and proposals made to provincially regulate the siting of plants in response to local opposition to new gas generation.

Contentious Plants - Greenfield South

- Greenfield South is a 280 MW combined cycle gas fired generating plant that was procured through a 2005 competition conducted by the Ministry of Energy and the contract is now managed by the OPA
- The plant is located in southern Mississauga near the Etobicoke border. The plant is only now under construction as a result of several municipal and other permitting delays.
- The project's approval was delayed due to City of Mississauga opposition at the Environmental Approval and building permitting stages. As a result, the facility's contract was renegotiated to extend the operational date to the third quarter of 2014.
- The Ontario Municipal Board reviewed municipal planning and zoning in 2007 and determined that the site was properly zoned and suitable for this type of electricity generation facility.
- The Ministry of the Environment is conducting an updated review of the approval for the Greenfield South facility to assess recent developments. There is no fixed timeline for this review.



TransCanada Agreement (tentative CONFIDENTIAL)

- On September 30, 2009, the Ontario Power Authority announced that it would sign a contract with TransCanada Corporation to design, build and operate a 900 MW electricity generating station in Oakville. TransCanada estimated the cost of the plant at \$1.2 billion.
- On October 7, 2010, the government announced that the plant would not proceed.
- TransCanada, the Province and the OPA have signed an arbitration agreement related to the termination of the Oakville Generating Station project. The arbitration sets out the framework for the determination of the reasonable damages which TCE is entitled as a result of the termination of the contract.
- TransCanada, Infrastructure Ontario, OPG, and Ministries of Energy and Finance are seeking to negotiate non-financial options for settling the dispute that could include the transfer of assets or project development opportunities. The negotiations are ongoing.
- In the event an alternative agreement is not achievable, TransCanada would be able to pursue arbitration under the agreement set out.

Your email concerning the Greenfield South Generating Station has been forwarded to me for response.

Please understand that the Government of Ontario has set health, safety and environmental protection for individuals and communities as top priorities in the development of Ontario's electrical system.

The Greenfield South plant is replacing generation from the Lakeview coal plant and other coal plants which had a much higher health and environmental impact on your neighbourhood than the new gas plant.

The need for reliable supply to your community remains, and the combined cycle gas generation technology to be used at Greenfield South is the cleanest form of reliable generation available. The impact of the plant operation will be much less than other neighbourhood sources such as furnaces, vehicles, barbeques and yard equipment.

With respect to your concern about the environmental review process, Greenfield South's environmental report was subjected to a rigorous public and Ministry of the Environment review. Before any approvals were issued significant design and operational improvements were made to reduce environmental impact further.

While normally companies are only required to meet the standards and conditions that were applicable at the time the approvals were issued, the Ministry of the Environment is taking the unusual step to review the environmental impact of Greenfield South again to ensure that the plant meets or betters the current standards and conditions.

Gas and other fuelled generation facilities are commonly located and have operated safely within communities around the world, some large plants less than 200 meters from residences and other occupied buildings. Gas generation facilities at smaller scales are often attached to hospitals, to provide uninterruptible power.

Ontario's gas safety standards are very high and gas generating facilities are built and operated to the highest standards, so that they have proven to be of very low risk.

I understand that you will continue to have concerns about Greenfield South; this is common in many communities when generating facilities have been introduced. This happened, for example, when Toronto's Portlands Energy Centre, a 550 MW gas generating plant, was being planned and built. Portlands has now operated for several years without complaint or concern expressed by the local community, and it has become a destination for plant tours by the public.







On October 7, 2010, Minister Duguid announced that the plant had been cancelled. The OPA is negotiating termination of the contract with TransCanada.

Potential non-GTA procurement (Kitchener-Waterloo-Cambridge):

The Kitchener-Waterloo-Cambridge-Guelph area is a major automotive and "high tech" centre and is experiencing rapid population and economic growth. Peak demand is 1,400 MW and has been increasing at a rate double the provincial average. The region is host to several data centres that require a reliable power supply

 During the development of the IPSP, the OPA determined that for reliability and security reasons, and to contribute to coal replacement, additional simple cycle gas-fired electricity supply of 450 MW would be required.

New Natural Gas-Fired Generation

- Natural gas-fired generation has a relatively low cost compared to most other sources of new generation. The large natural gas generation facilities can be dispatched to provide power when it is needed. Natural gas is helping to replace coal-fired generation and integrate intermittent renewable generation leading to lower carbon emissions from Ontario's electricity mix.
- Through various Ministerial directions, the OPA has procured 5,277 megawatts (MW) of new natural
 gas-fired generation capacity of which 4,154 MW is already operating. The OPA has indicated a need to
 procure one additional new plant of approximately 450 MW in the Kitchener-Waterloo-Cambridge
 area.
- Four plants located in the GTA have been the subject of strong local municipal and public opposition.
 Portlands Energy Centre in Toronto has been built and operating for several years and is no longer contentious.
- There have been calls and proposals made to provincially regulate the siting of plants in response to local opposition to new gas generation.
- If there are further delays or cancellation of new gas-fired generators, it could lead to decreased reliability during periods of peak demand in areas around the new facilities.

GTA Plants - Greenfield South

- Greenfield South is a 280 MW combined cycle gas fired generating plant that was procured through a 2005 competition conducted by the Ministry of Energy and the contract is now managed by the OPA.
- The plant will be built and operated by Eastern Power Ltd and is located in southern
 Mississauga near the Etobicoke border. The plant is only now under construction as a
 result of several municipal and other permitting delays.
- The project's approval was delayed due to City of Mississauga opposition at the Environmental Approval and building permitting stages. As a result, Eastern Power's contract was renegotiated to extend the operational date to the third quarter of 2014.
- The Ontario Municipal Board reviewed municipal planning and zoning in 2007 and determined that the site was properly zoned and suitable for this type of electricity generation facility.
- The Ministry of the Environment is conducting an updated review of the approval for the Greenfield South facility to assess recent developments. There is no fixed timeline for this review.



TransCanada Agreement (tentative CONFIDENTIAL)

- On September 30, 2009, the Ontario Power Authority announced that it would sign a contract with TransCanada Corporation to design, build and operate a 900 MW electricity generating station in Oakville. TransCanada estimated the cost of the plant at \$1.2 billion.
- On October 7, 2010, the government announced that the plant would not proceed.
- TransCanada, the Province and the OPA have signed an arbitration agreement related to the termination of the Oakville Generating Station project. The arbitration sets out the framework for the determination of the reasonable damages which TCE is entitled as a result of the termination of the contract.
- TransCanada, Infrastructure Ontario, OPG, and Ministries of Energy and Finance are seeking to negotiate non-financial options for settling the dispute that could include the transfer of assets or project development opportunities. The negotiations are ongoing.
- In the event an alternative agreement is not achievable, TransCanada would be able to pursue arbitration under the agreement set out.



Mississauga is again in the news. Community activists are pressuring the Government

I am extremely concerned that construction of the Greenfield South power plant in the City of Mississauga is ongoing.

As I am sure you are aware, the site backs onto the Etobicoke Creek, a hospital, residential areas, and new condomimiums that were not taken into consideration in the initial approvals of the project.

I greatly appreciate that Minister John Wilkinson has decided to review the MOE's decision to review the approval for the plant. I understand that MOE issued a certificate of approval in 2008, but with the changes in the provincial energy picture and the surrounding land use changes, the project needs to be called into question. The initial approvals were granted when local, gas-fired powered generation was seen to be the right solution, but seemingly the picture has changed given the recent decision in Oakville. I think it's important for residents to know whether this is the right source of energy, if needed at all, and whether our airshed in the western and downtown portions of Toronto is any less sensitive than that in Oakville.

Simply stated, the plant seems unnecessary and potentially dangerous to public health and safety, it is too close to residential and environmental areas, and will have detrimental cumulative impacts on the airshed. Just like the Oakville plant, the Greenfield South Power Plant needs to be axed by Minister John Wilkinson and Premier Dalton McGuinty.

Please advise as to the status of the review of the Certificate of Approval and when the public can expect to see a decision on that review.

Ministry of Energy Media Scan Greenfield South Gas Power Plant September 26, 2010 - September 25, 2011

The attached articles, in reverse chronological order, cover the issue of a proposed gas plant near Sherway Gardens in Mississauga.

The Mississauga community was already sensitized to the issue of gas-fired power plants when news emerged this spring that a building permit had been issued to Eastern Power for a gas-fired plant on Loreland Avenue near the border between Toronto and Mississauga. Last fall, a proposed gas-fired power plant to be sited near the Mississauga-Oakville border met with fierce opposition from the community. MPPs Kevin Flynn and Charles Sousa had spoken out against this plant. When the province moved to cancel the Oakville plant, Flynn published a letter to the editor of InsideHalton ("Reason to be proud", October 28, 2010). Two of his remarks in the letter are notable: "I would like to confirm that not only will the Oakville plant be stopped, but neither will it be built anywhere in the SWGTA including Mississauga" and "The Green Energy Act has allowed for the creation of 8000 MW of new energy and increased conservation and actually allowed our government to stop this plant."

The first news coverage in the past year of the Greenfield South Power Corporation gas plant issue came on June 2, 2011 when Chris Clay revealed a building permit had been issued for the plant. ("Permit issued for power plant", Mississauga News). Prior to that, the issue had been dormant for some years. The Ontario Municipal Board had ruled in 2007 against an appeal from the city calling for a stop to the plant.

A week later, Etobicoke Centre MPP and former energy minister Donna Cansfield published a letter to the editor of Mississauga News in which she stated that she opposed the plant ("Oppose the power plant", Mississauga News, June 9, 2011). This letter was also discussed in a news article two days later (Former minister fights against power plant", Mississauga News, June 11, 2011) and two weeks later ("MPP rebels against own government", Toronto Star, June 22, 2011).

On June 13, 2011 the Toronto Star reported that the plant was becoming an election issue ("Power plant becomes election issue"). Two days later, on June 15, Noel Grzetic reported for InsideToronto that MOE would review the plant ("MOE to review power plant", InsideToronto, June 15, 2011).

On June 20, 2011 the Premier commented on the issue ("McGuinty weighs in on power plant", Toronto Star, June 20, 2011). His remark "There's never a wrong time to do the right thing" was often referenced in the weeks and months to come.

The issue continued to be discussed, but not with direct criticism of the provincial government, for the next month. Then on July 25, it was reported that construction was going ahead on the site. This spurred new criticism from citizens doubtful that the province was likely to stop a plant that was already being built ("Power plant moves ahead", Mississauga News/Torstar, July 25, 2011).

On July 28, 2011 Greenfield South held a public meeting to discuss the power plant. A large number of residents forced their way into the meeting ("Residents storm public meeting over future power plant", Etobicoke Guardian, July 28, 2011) and heckled the proceedings.

Citizens held a public rally on September 15 to protest the plant ("Residents rally against Mississauga power plant", Toronto Star, September 16, 2011).

The next news on this issue was the Liberal promise to scrap the plant if they are re-elected to government ("Liberals scrap power plant", Toronto Star, September 24, 2011). Response to this news has been somewhat critical, particularly from the Toronto Sun ("Another grit flip-flop; Liberals say they'll work to move power plant that was their idea in the first place", Toronto Sun, September 25, 2011").

Below is material from our HN pertaining to Greenfield South. This has some of the key information about the plant as well as its approvals. Let me know if there's anything else you need.

Greenfield South

- Greenfield South Generating Station is a 280 MW combined cycle natural gas plant located in the City of
 Mississauga on a 4.5 hectare property at 2315 Loreland Avenue. Part of the project's property will be
 dedicated to the City as greenbelt, and the plant will occupy roughly 2 hectares of the property.
- Eastern Power Ltd. is an equity contributor to Greenfield South Power Corporation, and is responsible for the project's design, engineering, and management, and provides operations and maintenance support. No information is available on any other partners.
- The plant is 200 metres from the nearest residence, 700 metres from the nearest hospital and 1.1 km from the nearest school.
- The plant was selected in the Ministry of Energy Clean Energy Supply competition and holds a contract with the OPA.
- Approvals delays resulting from City of Mississauga opposition to the project at the EA and building permitting stages harmed the economic viability of the project.
- The Ontario Municipal Board reviewed municipal planning and zoning in 2007 and determined that the site was properly zoned and suitable for this type of electricity generation facility.
- The project obtained environmental approval in 2008 from the Ministry of the Environment.
- The City of Mississauga issued a building permit on May 31, 2011 for the building that will house the generation equipment.
- The contract between Greenfield South and the Ontario Power Authority was renegotiated as a result of approvals delays, to extend the operational date.
- As of March 18, 2011, the OPA and Greenfield South have agreed to a new COD: Q3 2014.

- Greenfield intends to proceed with the project and has previously indicated that they would pursue litigation if the City or the province moved to prevent the plant from being built.
- Delays in the COD will exacerbate supply problems in the southwest GTA.
- The proponent has stated that all financing needed for construction of the project was finalized in May 2011. Public reports indicate that \$250 million in financing was provided by Morgan Stanley and EIG Global Energy Partners.
- As of July 20th, the proponent reports that it has begun to lay the foundations for the gas and steam turbine halls.
- Purchase orders for all of the plant's major equipment including the turbines and generators have been placed.
- Residents in the surrounding community have reacted negatively because they assumed the project was not proceeding.
- On July 28th, the proponents will be holding their first monthly local liaison meeting to help foster communication with local residents.
- On June 16th, the Minister of the Environment John Wilkinson announced that the Ministry of the Environment will conduct an updated review of the approval for the Greenfield South facility to assess recent developments. The review will take as long as the ministry needs to confirm that the project can proceed in a manner that is fully protective of public health and the environment.
- The Environmental Approval for the generating plant is specific to the site, and is not transferable.

BACKGROUND

- Greenfield South Generating Station is a 280 MW combined cycle natural gas plant located in the City of Mississauga on a 4.5 hectare property at 2315 Loreland Avenue (the "Greenfield project").
- The Greenfield project arose out of a Clean Energy Supply (CES) procurement process arising out of ain 2004. Clean Energy Supply (CES) Ministerial Procurement, where such This contract, with Greenfield South Power Corporation, swasere eventually passed to assumed by the OPA. One of the CES contracts was awarded to Greenfield South Power Corporation (the proponent).
- The project is importantwas undertaken to meeting local reliability needs for the Southwest and Western GTA_τ and has been positioned as part of the coal closure strategy.
- The plant is 200 metres from the nearest residence, 700 metres from the nearest hospital and 1.1 km from the nearest school.
- Currently there are four Liberal candidates in Etobicoke and Mississauga, Donna Cansfield, Charles Sousa (in his riding), Laurel Broten, and Dipika Damerla, who have referred to terminating the Greenfield South project.

Approvals and Commercial Status

- In July, 2011, Greenfield reported proceeding with construction including laying foundations for the steam and gas turbine halls, and having placed orders for the major equipment (generators, turbines, etc.) involved.
- In June, 2011, MOE announced that it will conduct an updated review of the approval for the Greenfield South facility to assess recent developments. To date, no end-date was set for this process. In May, 2011, the proponent finalized its

financing arrangements and the City of Mississauga issued Building Permits for the building housing the generation equipment.

- In March, 2011, OPA renegotiateds the initial Commercial Operation Date (C.O.D.) with the proponent, Greenfield Power Corp., in recognition of the lengthy regulatory approvals and financing delays experienced by Greenfield South. The new C.O.D. is the third quarter (Q3) of 2014.
 - In 2008, MOE had granted all necessary environmental approvals.
 - However, there was a lengthy period of force majeure (suspension of time pending resolution of regulatory and approval issues) resulting from approval delays;
 - Greenfield South experienced two years of regulatory delays before MOE rendered its final decision denying a request for elevation.
 - In 2007, the Ontario Municipal Board reviewed and approved of the zoning of the project site after a lengthy and protracted process.

Legal Options for Cancelling Greenfield South Contract

- Cancellation of the project at this stage would involve the termination of the OPA contract by the parties on a commercial basis or by the OPA acting on instructions contained in a Ministerial Direction.
- Further study of the specific contract itself and the provisions sought to be utilized in any given scenario would be necessary to provide further certainty on remedies available to each party.
- Any action by the City or the Ministry, and presumably the OPA, which involved the cancellation of the Greenfield South Project carries the high risk of litigation, since the proponent may be quite prepared to bring suit to protect its financial interests, including development costs incurred to date.
- Note that an initial review of our records reveals that. LSB had not been asked to
 provide advice on this particular contract during any recent timeframe.
