Major work is continuing on a controversial Mississauga gas-fired power plant one month after Premier Dalton McGuinty's campaign pledge to stop it.

Progressive Conservative Leader Tim Hudak unveiled photographs taken Monday showing a huge generator en route to the site near Sherway Gardens.

"This Mississauga power plant was supposed to have been cancelled by Dalton McGuinty during the election campaign," Hudak told reporters at Queen's Park.

"It's now 18 days later and the plant is . . . (still being) built. In fact, this is the most expensive component of what's probably a \$300 million to \$400 million project.

"Are they now breaking a promise only three weeks after the election?" he said, suggesting McGuinty is up to "the same old tricks to waste money."

On Sept. 24, in a surprise move just 12 days before the tightest election in decades, the Liberals revealed the 280-megawatt plant would be moved to a different location.

The Saturday announcement — deliberately withheld from political journalists covering the campaign by order of senior Grits, who wanted only less critical local media in attendance — was designed to save the party's seats in Mississauga and Etobicoke.

It was a successful strategy as all area Liberals were re-elected on Oct. 6.

But in a brief statement Monday, newly minted Energy Minister Chris Bentley, who was not available for comment, had no explanation for why the work is continuing.

"The Ontario government is committed to relocating the natural gas plant originally planned for Mississauga," said Bentley, adding the Liberals would "work with the company to find a suitable location for this plant."

"More information will become available as discussions progress."

Liberal sources confirmed "preliminary" talks are underway with Eastern Power, which is building the plant.

NDP Leader Andrea Horwath said Ontarians need some straight answers from the government.

"What the Liberals should do is to tell the people of Ontario how much it's going to cost to cancel that gas plant, to start taking it apart instead of building it," said Horwath.

"That's a commitment they made to the people of those ridings," she said.

Eastern Power did not return calls or email messages from the Star on Monday.

During the campaign, McGuinty made no apologies for intervening because the area has become much more developed with condos and other housing since the plant was originally proposed.

"We've got to be very careful where we locate these kinds of things," he said last month.

The arrival of a massive generator at a supposedly unplugged Mississauga power plant site Monday will only jack up the tab for Ontario taxpayers when the facility is finally relocated, PC Leader Tim Hudak says.

"This Mississauga power plant is supposed to have been cancelled by Dalton McGuinty during the election campaign. It's now 18 days later and the plant is (continuing) to be built. In fact, this is the most expensive component of what's probably a \$3-\$4 million project," Hudak said.

The Ontario Tories released photos of the generator on route to the south Mississauga location Monday, a month to the day after McGuinty told voters in the area that he would stop it if re-elected.

Hudak said the premier must explain why construction continues on the site and how much taxpayers will eventually be forced to pay in compensation to the private owner of Greenfield South Power Plant.

Energy Minister Chris Bentley issued a statement Monday in response to the Tory complaints but was unavailable for questions from the media.

"The Ontario government is committed to relocating the natural gas plant originally planned for Mississauga," Bentley says.

"The government will work with the company to find a suitable location for this plant. More information will become available as discussions progress."

Hudak said he wonders if McGuinty may be rethinking his sudden opposition to the plant after years of support.

"I do worry that the premier's starting out the new session already breaking promises out of the gate.

"And clearly with the single biggest component going to the power plant, I'm worried he's going to flip flop and break his promises," he said. NDP Leader Andrea Horwath said the premier needs to follow through on his commitment but "what the Liberals should do is tell the people of Ontario how much it's going to cost to cancel that gas plant, to start taking it apart instead of building it."

A representative for Greenfeild South Power Plant, and its affiliate Eastern Power Limited, could not immediately be reached for comment.

A company website says the natural gas-fired generating facility is similar to plants found in urban areas including London, New York and Los Angeles.

It's been a year since the McGuinty Liberals cancelled another planned gas-fired generation plant in Oakville.


 Greenfield South Generating Station is a 280 MW combined cycle natural gas plant located in the City of Mississauga on a 4.5 hectare property at 2315 Loreland Avenue. Part of the

project's property will be dedicated to the City as greenbelt, and the plant will occupy roughly 2 hectares of the property.

- Eastern Power Ltd. is an equity contributor to Greenfield South Power Corporation, and is responsible for the project's design, engineering, and management, and provides operations and maintenance support. No information is available on any other partners.
- The plant is 200 metres from the nearest residence, 700 metres from the nearest hospital and 1.1 km from the nearest school.
- The plant was selected in the Ministry of Energy Clean Energy Supply competition and holds a contract with the OPA.
- Approvals delays resulting from City of Mississauga opposition to the project at the EA and building permitting stages harmed the economic viability of the project.
- The Ontario Municipal Board reviewed municipal planning and zoning in 2007 and determined that the site was properly zoned and suitable for this type of electricity generation facility.
- The project obtained environmental approval in 2008 from the Ministry of the Environment.
- The City of Mississauga issued a building permit on May 31, 2011 for the building that will house the generation equipment.
- The contract between Greenfield South and the Ontario Power Authority was renegotiated as a result of approvals delays, to extend the operational date.
- As of March 18, 2011, the OPA and Greenfield South have agreed to a new COD: Q3 2014.
- Greenfield intends to proceed with the project and has previously indicated that they would pursue litigation if the City or the province moved to prevent the plant from being built.
- Delays in the COD will exacerbate supply problems in the southwest GTA.
- The proponent has stated that all financing needed for construction of the project was finalized in May 2011. Public reports indicate that \$250 million in financing was provided by Morgan Stanley and EIG Global Energy Partners.
- As of July 20th, the proponent reports that it has begun to lay the foundations for the gas and steam turbine halls.
- Purchase orders for all of the plant's major equipment including the turbines and generators have been placed.
- Residents in the surrounding community have reacted negatively because they assumed the project was not proceeding.
- The proponents will be holding monthly local liaison meetings to help foster communication with local residents.
- On June 16, the Minister of the Environment John Wilkinson announced that the Ministry of the Environment will conduct an updated review of the approval for the Greenfield South facility to assess recent developments. The review will take as long as the ministry needs to confirm that the project can proceed in a manner that is fully protective of public health and the environment.
- The Environmental Approval for the generating plant is specific to the site, and is not transferable
- On September 24th, several media outlets reported on the Liberal party's campaign commitment to relocate the proposed Greenfield South generating station to a location outside Mississauga and Oakville.
- In a news release, Ontario Liberal candidates Charles Sousa, Donna Cansfield, Laurel Broten
 and Dipika Damerla said the party would work with the developer to find a new location for the
 plant.
- The Ministry of the Environment's updated review of the approval for the plant is still
 ongoingOn October 24, 2011, as the result of a release from the leader of the Opposition,
 several media reported on the continuing construction at the site, including delivery of a

- The plant's original planned commercial operation date was 2009.
- Approval delays resulting from City of Mississauga opposition to the project at the
 environmental approval and building permitting stages harmed the economic viability
 of the project. The contract between Greenfield South Power Corporation and the
 OPA was renegotiated, and the commercial operation date has been extended to
 the third quarter of 2014.
- The project obtained zoning approval in 2007 and environmental approval in 2008.
- The OPA was advised on May 31, 2011 that the company has received its building permit for the plant. The company is moving equipment to the site, and excavation and foundation work is expected to start in early July.
- The site is located in a predominantly industrial area. It is bounded by a railway line, a transmission corridor and the Queen Elizabeth Way.
- The Ontario Municipal Board reviewed municipal planning and zoning and determined that the site was properly zoned and suitable for this type of electricity generation facility.
- Residents in the surrounding community have reacted negatively because they assumed the project was not proceeding.

Note:

In April 2005 Eastern Power was awarded contracts for two 280 MW natural gas plants – one for Greenfield South and one for Greenfield North (Hurontario St. north of Derry Road). In August 2005 Greenfield North contract terminated under a mutual agreement between the OPA and Eastern Power because Eastern Power was not able to obtain financing. The Greenfield South contract remained in place. At the time, Eastern Power said it preferred the Greenfield South site because it was better for natural gas supply and electrical connection and the area was zoned for industrial activity, including power generation.

QUESTIONS AND ANSWERS

Need:

Ontario has been selling electricity to neighbouring provinces and states. If we have electricity to spare, why do we need to build the Greenfield South plant?

The Greenfield South plant won't operate continuously. It is designed to compliment our baseload supply and it will operate only when electricity supply is needed, during periods of higher demand and to improve the reliability of supply to the local community. The plant will not be called on to run at other times.

How often will the plant operate?

Actual operation of the natural gas plant will depend on several factors including weather, demands on the electricity system and availability of other sources of power.

It is expected to operate about 10% to 45% of the time. Natural gas plants supplement power from other sources of supply including nuclear, water, wind and solar and support local reliability.

Can't other resources, such as renewable energy and conservation, replace the need for this plant?

This plant is designed to operate only during times when it is needed – when demand is high and supply from hydro, wind, solar and nuclear is not enough, or when needed for local reliability.

Natural gas plants can be controlled and relied on to provide supply when it is needed. Natural Gas complements the supply from renewable resources like wind and solar.

Conservation helps reduce demand on the electricity system and is a cornerstone of Ontario's Long-Term Energy Plan. Ontario has saved more than 1,700 megawatts of electricity over the last six years, equivalent to more than half a million homes being taken off the grid. We have set the most aggressive targets in North America for conservation.

Mayor Hazel McCallion has called for the plant's cancellation, claiming the plant is unnecessary. She says the plant is too close to residential areas and that the need for electricity in Mississauga has been "seriously miscalculated" by the OPA. If there isn't a significant demand for increased electricity in the city, why do we need to build the Greenfield South plant there?

This area, known as west GTA, is experiencing rapid population growth that will need additional local power capacity to meet reliability needs. Not putting a plant

here will increase the risk of local outages, as well as the response time to outages.

The Ministry of the Environment has announced that it will be reviewing the Certificate of Approval to reassure the community that this project is safe. Some factors have changed since the last environmental approval process; the area surrounding the plant now includes high-rise buildings.

Permits/Approvals and Construction Start Date:

What permits and approvals does the plant need to start construction? Has it obtained all these permits/approvals?

The project obtained zoning approval from the Ontario Municipal Board in 2007 and environmental approval in 2008 from the Ministry of the Environment.

The City of Mississauga recently issued a building permit on May 31, 2011 for the building that will house the generation equipment.

When will construction start on the plant?

The City of Mississauga recently issued a building permit for the building that will house the generation equipment. The company is moving equipment on to the site, and excavation and foundation work is expected to start in July.

Questions regarding the construction schedule should be directed to the company.

I haven't heard anything about this project for a long time. Why is it going ahead now?

The project was before the Ontario Municipal Board and has only recently received building permits from the City of Mississauga.

Health and Safety:

Why is the plant being built so close to homes, a health centre, a school and a shopping mall? Why can't it be built in a less populated area?

Ensuring the safety of the community and protecting the local environment is our government's top priority. The Ministry of the Environment will examine the approval for Greenfield to provide assurances to the local community that the health and safety studies that were conducted at the time still hold true today.

It's common practice around the world for plants of this size to be located in urban areas so they are close to the area that they are intended to supply. For example, the Portlands Energy Centre in downtown Toronto is a 550 MW natural

gas plant in a major urban centre. It provides about 25% of downtown Toronto demand.

What about the health of area residents, particularly those with respiratory problems? Won't emissions from the plant harm the local air quality?

Ensuring the safety of the community and protecting the local environment is our governments' top priority. The Ministry of the Environment will examine the approval for Greenfield to provide assurances to the local community that the health and safety studies that were conducted at the time still hold true today.

The plant is required to meet stringent emissions requirements. It will establish a community advisory committee and has committed to monitor the air quality in the vicinity and monitor emissions to ensure the protection of health and the environment.

The procurement for the cancelled SW GTA natural gas plant required bidders to meet standards 70% tougher than Ministry of the Environment requirements. Were the same standards used for this procurement? If not, why?

The requirement was specific to the Oakville plant procurement. That's like comparing apples and oranges. The proposed Oakville plant was about three times the size of the Greenfield plant and had not received any environmental approvals.

The Oakville process also followed the release of the Clarkson Airshed Study. While the Greenfield South plant is not part of the Clarkson Airshed, it will have to meet strict standards for emissions that will be enforced with mandatory emissions monitoring and reporting.

What about proximity to the Etobicoke Creek? Does this plant pose any potential risks to the creek or local drinking water?

The McGuinty government has made protecting our water a top priority. Our drinking water is now the safest in North America. The project will not take water from Etobicoke Creek for process use and will not discharge any process water into the creek.

The site is not on a floodplain as established by Toronto and Region Conservation Authority.

There will also be a buffer zone and erosion control at the site.

We are satisfied that all storage tanks located on the site will continue spill protection features in accordance with regulatory requirements and this will ensure that the potential for a spill entering Etobicoke Creek is minimized. Greenfield South agreed to the removal of the option of burning diesel fuel from

the contract in 2009, so fuel oil will not be stored. Natural gas is the only fuel source for the plant.

How can you justify building a plant when there were explosions at natural gas plants in Connecticut and California?

The province has a strong safety record when it comes to Natural gas plants. They are designed and operated to a very high safety standard. The incident in Connecticut was the result of construction practices that are illegal in Ontario. The California pipeline explosion was the result of design and operation standards that were much less stringent than Ontario standards. The Technical Standards and Safety Authority applies world-class standards.

Site selection:

How and why was this site selected? What other locations were considered?

Greenfield South was selected through a competitive Request for Proposals (RFP) process in 2004 and will be built on an industrial site zoned for electricity generation. The proposal was reviewed by an independent evaluation team and the process was overseen by an independent fairness commissioner.

The site is located in a predominantly industrial area. It is bounded by a railway line, a transmission corridor and the Queen Elizabeth Way.

Setbacks:

How would Bill 8, Separation Distances for Natural Gas Power Plants Act, 2010, apply to this plant if it is passed? Haven't you said you are now discussing how to move forward on setbacks for natural gas plants?

The planned plant complies with current regulations. The company has received a building permit, and excavation and foundation work is expected to start in July, according to the company. Any discussions regarding future regulations would apply to projects on a go forward basis.

How can you justify having provincial setbacks for wind projects, but not for natural gas projects? If this plant was a wind turbine, it couldn't be built because of its proximity to homes.

Wind turbine setbacks are designed on established standards for noise mitigation. Natural gas generating equipment can be enclosed and noise mitigated so plants can be located less than 200 meters from homes or schools and still operate well below the Ministry of the Environment noise requirements.

Set backs are determined by the municipality. Safety is regulated by TSSA. Our contracts require that proponents comply with all municipal, environmental, and safety regulations.

Consultation:

What opportunity have local residents had to have input into this project?

The Greenfield South Power Corporation engaged in extensive public consultation through the environmental review process. There were public notices in local newspapers; the company held a public open house and a public forum was hosted by local citizens. The company made several positive changes to its design in response to public concern and Ministry of the Environment requests.

These include:

- Conducting ambient air monitoring in the vicinity of the facility for a period of two years to help clarify potential health impacts
- Conducting stack emissions monitoring to ensure compliance with stringent standards
- Establishing a community advisory committee, preparing an annual report on mitigation measures and impact management activities, and making the report publicly available
- Sharing information on emissions and other monitoring activities with the community through the advisory committee.

How can you say there has been extensive public consultation when concerned residents were pushing for an individual Environmental Assessment for this project and the government refused these requests?

Ensuring the safety of the community and protecting the local environment is our government's top priority. The project underwent a rigorous environmental review process and was granted a Certificate of Approval in 2008.

The Ministry of the Environment will examine the approval for Greenfield to provide assurances to the local community that the health and safety studies that were conducted at the time still hold true today.

Any specific concerns regarding the environment review or approval processes should be directed to the Ministry of the Environment.

What happens if the project doesn't hold up to today's standards? When will we know this? Wouldn't it make sense to delay construction until current approvals are in place?

Companies are required to meet the most current ministry standards as well as all the conditions in their Certificates of Approval. During the approval process,

the company was required to provide information to demonstrate that it would be able to meet the standards which are now in place.

However, the Ministry of the Environment will examine the approval for Greenfield to provide assurances to the local community that the health and safety studies that were conducted at the time still hold true today.

I thought the contract was supposed to expire years ago? What was its original expiry and why was it renegotiated/extended? What's the new inservice date?

The plant's original commercial operation date was 2009. The project faced delays in obtaining municipal zoning approvals and some other permitting. Because these delays were beyond the proponent's control, the project was on hold for an extended period of time. The in-service date was extended because of the delays and the new in-service date is the third quarter of 2014.

Cost:

How much will this plant cost to build and how much will Greenfield South get paid for the power produced by this plant?

The contract was part of a competitive procurement and the terms are commercially sensitive.

What effect will adding this plant have on electricity prices?

The cost of generation from competitively procured natural gas plants has proven to be relatively low. This costs associated with this project are built into the cost projections provided in the Long-Term Energy Plan.

LTEP:

Why is this plant not referenced in the LTEP?

The LTEP talked about uncontracted facilities. Greenfield South and Northern York Region are both already contracted.

Are there other contracted facilities we should know about?

Greenfield South and Northern York Region are the only OPA contracted natural gas facilities that are not already built and supplying electricity.

On Page 34 of the LTEP it says that 2 of the 3 natural gas plants – including Oakville - from the 2007 Plan are no longer needed, and that the only plant we need to proceed with is the Kitchener Waterloo Cambridge plant. What was that other plant that was no longer needed?

The three uncontracted natural gas plants from the 2007 Integrated Power System Plan were SW GTA (Oakville), a 550 MW plant in the GTA and Kitchener Waterloo Cambridge. When the LTEP was developed the first two were no longer considered required resources. Two contracted natural gas plants (North York and Greenfield South) were included in the analysis, but not referenced explicitly in the text, as they were already under contract.

Cancellation of Oakville Plant:

When the Oakville plant was cancelled, the reason given was that the demand picture had changed. If that's the case, why is this plant being built?

The proposed Oakville plant was about three times the size of this plant. Our analysis showed a plant that large was not required. Generation from Greenfield South was taken into consideration in the Oakville plant decision and our analysis and planning scenarios.

When the Oakville plant was cancelled, didn't you say there would be no new natural gas plant built in the area?

This was to clarify that the proposed 900-megawatt plant would not be relocated elsewhere in the area. The Greenfield South plant is an existing contracted project, not a proposal for a new plant.

What about the transmission solution? When the Oakville plant was cancelled you said a transmission solution can ensure the area will have enough electricity.

The Greenfield South plant won't operate continuously. It is designed to operate only when electricity supply is needed, during periods of higher demand and for local reliability. This will improve the reliability of supply to the local community and to the larger electricity system.

In addition to this small plant, a transmission solution is also required to help maintain a reliable and secure supply of electricity in the Oakville, Mississauga and the west GTA. Reinforcement of the bulk transmission system in the western GTA, particularly in the Milton area, is also still required.

What is the status of negotiations with TransCanada over the cancellation of the Oakville plant?

We are in discussions with TransCanada, and do not have an update at this time.

Why not build the natural gas plant in Nanticoke instead? They've indicated they're a willing host community.

The sites aren't interchangeable. The west GTA requires additional power capacity for local reliability. Greenfield South is part of the solution. In addition to

this plant, the OPA is also looking at transmission options for the West GTA which would bring in power from other parts of the province, including Nanticoke.

Will a natural gas plant be built in the Kitchener-Waterloo-Cambridge-Guelph area?

As indicated in the Long-Term Energy Plan the procurement of a natural gas plant in the Kitchener-Waterloo-Cambridge area is necessary.

The Kitchener-Waterloo-Cambridge area is a major automotive and high-tech centre and is experiencing rapid population and economic growth. Peak demand has been increasing at a rate double the provincial average. The region is host to several data centres that require a reliable power supply.

How many natural gas plants are there already operating in the GTA?

There are four major plants:

- The 550-megawatt Portlands Energy Centre near downtown Toronto
- The 874-megawatt Goreway Station in Brampton
- The 683-megawatt Halton Hills Generating Station
- A 117-megawatt cogeneration plant at the Toronto International Airport in Mississauga

In addition there are a number of smaller natural gas generating plants operating in industry, and in commercial and institutional complexes, including universities and hospitals, including:

- A 68-megawatt facility at the Ottawa Health Sciences Centre
- A 6.6-megawatt facility at Brock University in St. Catherines
- A 2.3-megawatt district energy facility at <u>Durham College in Oshawa</u>
- A 12-megawatt cogeneration facility in London
- A 5-megawatt cogeneration facility in Sudbury
- A 6.7-megawatt cogeneration facility at Sudbury hospital







The company specializes in various aspects of energy plant development, including construction, landscaping and environmental consulting. Eastern Power also owns and operates the Keele Valley and Brock West landfill gas generating stations.
- Greg Vogt is the president of Eastern Power.
- Hubert Vogt is vice-president of Eastern Power.

- The Ontario Municipal Board reviewed municipal planning and zoning and determined that the site was properly zoned and suitable for this type of electricity generation facility.

Note:

In April 2005 Eastern Power was awarded contracts for two 280 MW natural gas plants – one for Greenfield South and one for Greenfield North (Hurontario St. north of Derry Road). In August 2005 Greenfield North contract terminated under a mutual agreement between the OPA and Eastern Power because Eastern Power was not able to obtain financing. The Greenfield South contract remained in place. At the time, Eastern Power said it preferred the Greenfield South site because it was better for natural gas supply and electrical connection and the area was zoned for industrial activity, including power generation.

Since the election, we've received only 8 items of correspondence related to the Mississauga gas plant.

One was a Mississauga council resolution sent by Mayor Hazel McCallion and forwarded by the Premier, requesting government take immediate action to cancel Mississauga gas plant.

We have received 5 emails from the public asking why the plant hasn't been cancelled yet. These range from short questions like: "Can you confirm [the plant] has been cancelled as per Premier McGuinty's election promise?" and "Why have you not pulled the plug on [the plant]?" to the following angry comment:

"Clearly the Liberals are looking like liars with this being the first and most public broken promise. Will relocating this plant jeopardize local power supply?

Does the area have enough supply in the meantime?

The Greenfield South plant was not intended to operate continuously. It was designed to complement our baseload supply and operate only when electricity supply is needed, during periods of higher demand and to improve the reliability of supply to the local community.

The plant would will not be called on to run at other times.

How often will the new plant operate?

Actual operation of the natural gas plant will depend on several factors including weather, demands on the electricity system and availability of other sources of power.

Greenfield was expected to operate about 10% to 45% of the time. Natural gas plants supplement power from other sources of supply including nuclear, water, wind and solar and support local reliability.

So we know for sure it will be a gas plant – and not additional transmission or other resources, such as renewable energy and conservation – that will replace this plant?

The OPA will be exploring options.

The Greenfield plant was intended to operate only during times when it was needed – when demand is high and supply from hydro, wind, solar and nuclear is not enough, or when needed for local reliability.

Natural gas plants can be controlled and relied on to provide supply when it is needed. Natural gas complements the supply from renewable resources like wind and solar.

What about the transmission solution? When the Oakville plant was cancelled you said a transmission solution can ensure the area will have enough electricity.

The Greenfield South plant won't operate continuously. It is designed to operate only when electricity supply is needed, during periods of higher demand and for local reliability. This will improve the reliability of supply to the local community and to the larger electricity system.

In addition to this small plant, a transmission solution is also required to help maintain a reliable and secure supply of electricity in the Oakville, Mississauga and the west GTA. Reinforcement of the bulk transmission system in the western GTA, particularly in the Milton area, is also still required.

Will a natural gas plant be built in the Kitchener-Waterloo-Cambridge-Guelph area?

As indicated in the Long-Term Energy Plan the procurement of a natural gas plant in the Kitchener-Waterloo-Cambridge area is necessary.

The Kitchener-Waterloo-Cambridge area is a major automotive and high-tech centre and is experiencing rapid population and economic growth. Peak demand has been increasing at a rate double the provincial average. The region is host to several data centres that require a reliable power supply.

How many natural gas plants are there already operating in the GTA?

There are four major plants:

- The 550-megawatt Portlands Energy Centre near downtown Toronto
- The 874-megawatt Goreway Station in Brampton
- The 683-megawatt Halton Hills Generating Station
- A 117-megawatt cogeneration plant at the Toronto International Airport in Mississauga

In addition there are a number of smaller natural gas generating plants operating in industry, and in commercial and institutional complexes, including universities and hospitals, including:

- A 68-megawatt facility at the Ottawa Health Sciences Centre
- A 6.6-megawatt facility at Brock University in St. Catherines
- A 2.3-megawatt district energy facility at Durham College in Oshawa
- A 12-megawatt cogeneration facility in London
- A 5-megawatt cogeneration facility in <u>Sudbury</u>
- A 6.7-megawatt cogeneration facility at Sudbury hospital

WHAT RELOCATING GREENFIELD MEANS FOR OTHER PROJECTS

Are there other power projects set to break ground that you may reconsider?

No.

You said that about Mississauga, after you cancelled Oakville. How can we trust that you won't cave to pressure the next time?

Like any other business, energy partners work together to respond to changing conditions.

Energy needs are affected by a variety of factors such as the economy, weather, improving energy efficiency standards, etc.

Our energy planners will continue to consider these factors over time on case-bycase basis in the context of the province's current and future needs.

Communities object to wind power, yet they move ahead. This is the second gas plant cancelled in the past two years. Why the double-standard?

The circumstances surrounding the need for this plant changed Inote: I think the circumstances are still the same i.e. there is a need in this area – perhaps check with Ryan], as did the immediate development around the plant. The government has heard the community's concerns about this plant proceeding as originally prlanned prompting out intention to relocate the plant.

Does this speak to a need to have a more independent, arms-length process?

There is already a rigorous, arms-length approvals process in place including municipal approvals, an environmental review process and Certificate of Approval.

Will you reconsider new gas set-backs or a new siting process for plants of any kind?

What is the status of negotiations with TransCanada over the cancellation of the Oakville plant?

We are in discussions with TransCanada, and do not have an update at this time.

GENERAL BACKGROUND

- Greenfield South Generating Station is a 280-megawatt combined cycle natural gas
 plant located in the City of Mississauga on a 4.5 hectare property at 2315 Loreland
 Avenue. The plant will occupy roughly 2 hectares of the property. Part of the
 property will be dedicated to the city as a park.
- The plant is, 700 metres from the Trillium Health Centre and 1.1 km from the nearest school (Isna Elementary School). The nearest block of homes is about 250 metres south of the site.
- The plant was selected in the Ministry of Energy Clean Energy Supply competition in 2005 and holds a contract with the Ontario Power Authority (OPA).
- The plant's original planned commercial operation date was 2009.
- Approval delays resulting from City of Mississauga opposition to the project at the
 environmental approval and building permitting stages harmed the economic viability
 of the project. The contract between Greenfield South Power Corporation and the
 OPA was renegotiated, and the commercial operation date has been extended to
 the third guarter of 2014.
- The project obtained zoning approval in 2007 and environmental approval in 2008.
- The OPA was advised on May 31, 2011 that the company has received its building permit for the plant. The company is moving equipment to the site, and excavation and foundation work is expected to start in early July.
- The site is located in a predominantly industrial area. It is bounded by a railway line, a transmission corridor and the Queen Elizabeth Way.
- The Ontario Municipal Board reviewed municipal planning and zoning and determined that the site was properly zoned and suitable for this type of electricity generation facility.

Note:

In April 2005 Eastern Power was awarded contracts for two 280 MW natural gas plants – one for Greenfield South and one for Greenfield North (Hurontario St. north of Derry Road). In August 2005 Greenfield North contract terminated under a mutual agreement between the OPA and Eastern Power because Eastern Power was not able to obtain financing. The Greenfield South contract remained in place. At the time, Eastern Power said it preferred the Greenfield South site because it was better for natural gas supply and electrical connection and the area was zoned for industrial activity, including power generation.

Since the election, we've received only 8 items of correspondence related to the Mississauga gas plant.

One was a Mississauga council resolution sent by Mayor Hazel McCallion and forwarded by the Premier, requesting government take immediate action to cancel Mississauga gas plant.

We have received 5 emails from the public asking why the plant hasn't been cancelled yet. These range from short questions like: "Can you confirm [the plant] has been cancelled as per Premier McGuinty's election promise?" and "Why have you not pulled the plug on [the plant]?" to the following angry comment:

"Clearly the Liberals are looking like liars with this being the first and most public broken promise. I along with my friends and family voted Liberals specifically because of this Liberal campaign promise. I've driven by the plant and I still see that construction is moving ahead quickly which is extremely disturbing. Let it be known that "we the public" are outraged! The Liberals PROMISED to cancel the plant. With each day that passes we are losing yet more money and YOU and the Liberals are losing credibility fast. Why have the Liberals not issued a statement as to what is happening? Why has a stop-work order not been issued? Make no mistake we will not sit quietly on this until action is taken place fast and the plant is cancelled."

Media Scan Greenfield South Gas-Fired Power Plant

September 26, 2010 - October 26, 2011

The attached articles, in reverse chronological order, cover the issue of a proposed gas plant near Sherway Gardens in Mississauga.

Discussion of the gas plant issue appears to be slowing again, with only two articles covering the issue since yesterday – a talk radio political commentary segment (CJBQ 800 Belleville, 9:30am today) and a CBC TV video re-broadcasting a previous story.

Social media coverage:

- <u>Tribe Magazine</u> wrote, "@LibPressSec @Dalton_McGuinty Exactly when is the Oakville power plant work going to stop?"
 - <u>Liberal Press Secretary</u> wrote, "@tribemagazine Gov committed to relocating NG plant. Will work w/ company to find suitable alternative location. Discussions ongoing."
 - <u>Tribe Magazine</u> wrote, "@LibPressSec So the work on building the NG plant goes ahead anyway while discussions are ongoing?"
 - <u>Liberal Press Secretary</u> wrote, "@tribemagazine Will move plan, working w/ company - more information will be available as discussion progress."
- <u>StJacobsboy</u> wrote, "@LibPressSec @tribemagazine and yet the work has not even slowed. Why not just come out and say this is another liberal broken promise?"
 - <u>Liberal Press Secretary</u> wrote, "@StJacobsboy @tribemagazine the NG plant will be moved. Gov continues to work with the company."

The Mississauga community was already sensitized to the issue of gas-fired power plants when news emerged this spring that a building permit had been issued to Eastern Power for a gas-fired plant on Loreland Avenue near the border between Toronto and Mississauga. Last fall, a proposed gas-fired power plant to be sited near the Mississauga-Oakville border met with fierce opposition from the community. MPPs Kevin Flynn and Charles Sousa had spoken out against this plant. When the province moved to cancel the Oakville plant, Flynn published a letter to the editor of InsideHalton ("Reason to be proud", October 28, 2010). Two of his remarks in the letter are notable: "I would like to confirm that not only will the Oakville plant be stopped, but neither will it be built anywhere in the SWGTA including Mississauga" and "The Green Energy Act has allowed for the creation of 8000 MW of new energy and increased conservation and actually allowed our government to stop this plant."

The first news coverage in the past year of the Greenfield South Power Corporation gas plant issue came on June 2, 2011 when Chris Clay revealed a building permit had been issued for the plant. ("Permit issued for power plant", Mississauga News). Prior to that, the issue had been dormant for some years. The Ontario Municipal Board had ruled in 2007 against an appeal from the city calling for a stop to the plant.

A week later, Etobicoke Centre MPP and former energy minister Donna Cansfield published a letter to the editor of Mississauga News in which she stated that she opposed the plant ("Oppose

the power plant", Mississauga News, June 9, 2011). This letter was also discussed in a news article two days later (Former minister fights against power plant", Mississauga News, June 11, 2011) and two weeks later ("MPP rebels against own government", Toronto Star, June 22, 2011).

On June 13, 2011 the Toronto Star reported that the plant was becoming an election issue ("Power plant becomes election issue"). Two days later, on June 15, Noel Grzetic reported for InsideToronto that MOE would review the plant ("MOE to review power plant", InsideToronto, June 15, 2011).

On June 20, 2011 the Premier commented on the issue ("McGuinty weighs in on power plant", Toronto Star, June 20, 2011). His remark "There's never a wrong time to do the right thing" was often referenced in the weeks and months to come.

The issue continued to be discussed, but not with direct criticism of the provincial government, for the next month. Then on July 25, it was reported that construction was going ahead on the site. This spurred new criticism from citizens doubtful that the province was likely to stop a plant that was already being built ("Power plant moves ahead". Mississauga News/Torstar, July 25, 2011).

On July 28, 2011 Greenfield South held a public meeting to discuss the power plant. A large number of residents forced their way into the meeting ("Residents storm public meeting over future power plant", Etobicoke Guardian, July 28, 2011) and heckled the proceedings.

Citizens held a public rally on September 15 to protest the plant ("Residents rally against Mississauga power plant", Toronto Star, September 16, 2011).

The next news on this issue was the Liberal promise to scrap the plant if they are re-elected to government ("Liberals scrap power plant", Toronto Star, September 24, 2011). Initial response to this

news has been somewhat critical, particularly from the Toronto Sun ("Another grit flip-flop; Liberals say they'll work to move power plant that was their idea in the first place", Toronto Sun, September 25, 2011").

Through the weekend and into Monday, September 26, coverage has almost uniformly portrayed the Premier as being on the defensive about a move being described by opposition politicians as "desperate". A Canadian Press article by Diana Mehta, which was picked up in the Winnipeg Free Press and Hamilton Spectator, quotes PC Leader Tim Hudak as saying, "Chickens with their heads cut off would have more stability on energy decisions than these guys" ("McGuinty defends scrapping power plant as PCs pounce on 'desperate' Liberals", Canadian Press, September 25, 2011).

As of Tuesday, September 27, 2011, coverage ballooned to 15+ articles per day, mostly critical. The prevailing criticism continues to be that the decision is a costly "flip-flop" ("McGuinty won't say how much it would cost to scrap gas-fired plant", The Canadian Press, September 26, 2011 [this article also notes that the plant is "quickly becoming a hot-button election issue"]; "Grit flip-flop confusing", Toronto Sun, September 27, 2011; "Killing gas-fired power plants could cost province \$1B", Toronto Star, September 27, 2011; "Power play will burn Premier", National Post, September 27, 2011). Another strong current of criticism questions whether the plant really will be stopped, given that construction is continuing ("Web cam shows work still going on at Mississauga power plant site", Toronto Star, September 26, 2011; "Campaign promise not enough for Greenfield protesters", National Post, September 26, 2011; "Hudak doubts McGuinty killed power plant", London Free Press, September 27, 2011). Other articles contend that the decision to scrap the plant is a win for NIMBYism ("Ontario's NIMBY Premier", National Post, September 27, 2011). Mississauga Mayor Hazel McCallion is among the few voices who laud the decision ("Cancellation a victory for citizens: McCallion", National Post, September 27, 2011).

Coverage has begun to slow as of Wednesday, September 28, 2011, as media attention turns to last night's leaders' debate, in which the power plant was mentioned but not heavily emphasized. Two King Sentinel articles today question the Liberals for cancelling the Greenfield South plant but not the power plant in Holland Marsh, which also faces considerable local opposition ("Plant stopped in Mississauga, but not the Holland Marsh"; "Green Leader charges Liberals playing politics at the expense of Holland Marsh", both published online on September 28, 2011). Criticism of NIMBYism continued through yesterday and into today's press ("Dalton prefers Grit NIMBYs", Toronto Sun, published online September 27, 2011). Also, media continue to confirm that the gas plant is still being built ("Construction exec confirms power plant will continue to be built, for now", Globe and Mail, September 27, 2011; "Work continues on scrapped Mississauga power plant", Global TV, September 26, 2011).

As of Thursday, September 29, 2011, coverage has continued to ebb, with just five articles since yesterday. Tone still remains critical of a decision seen as political. Of particular note are a blog entry by Tom Adams which questions whether the government can really afford to go without the Greenfield South plant ("McGuinty Gas Power Plant Cancellation Blacks Out Truth", <u>Tom Adams Energy</u>, September 28, 2011), which was tweeted about five times yesterday, a National Post oped also by Adams condemning "the political nature of the announcement ("Stop playing with Ontario's electricity, National Post, September 29, 2011) and a Globe and Mail column by Adam Radwanski noting that the decision has hurt the Premier's image ("Liberal Leader's decisive image takes shock from power plant pledge", Globe and Mail, September 29, 2011). Radwanski also goes into detail on some of the background of the issue and why the government did not move sooner to cancel the plant.

The proposed closure of the plant has continued to be the subject of political discussion. While commentary in the days following the announcement was critical (most recently, National Post's John Ivison described the move as "brazen" – "Voters are in no mood for change", National Post, October 6, 2011), political commentators now suggest the move did not harm – and may have benefited - Liberal incumbents in the area ("McGuinty reverses Conservative trend in the GTA", Globe and Mail, October 7, 2011; "Determined Hudak clings to values in battle to revive Tory fortunes", Globe and Mail, October 5, 2011). However, the plant is seen as a difficult issue for the incoming Minister of Energy ("McGuinty faces tough choices for lean machine", Globe and Mail, October 19, 2011; "How bold can McGuinty afford to be?", Globe and Mail, October 13, 2011).

After some weeks of quiet on the issue on Twitter, Toronto Star's Robert Benzie wrote today, "Energy Minister Chris Bentley "committed to relocating the natural gas plant originally planned for Mississauga." #onpoli". The Globe and Mail's Adam Radwanski wrote today, "For those trying to follow the Mississauga gas-plant saga, the key point is that the Liberals basically announced an intent to cancel. (I) [...] So as far as I can tell, the company is keeping up work right to the actual cancellation, to get the best settlement. (II) [...] All of which makes for a less than enticing item on Chris Bentley's new to-do list. (III)"

On October 24, coverage flared up on the issue of gas power plant siting, as opposition leader Tim Hudak drew attention to ongoing construction at the Greenfield South site. The new Energy minister quickly made a statement: "The Ontario government is committed to relocating the natural gas plant originally planned for Mississauga. The government will work with the company to find a suitable location for this plant. More information will become available as discussions progress." While most articles are not strongly critical in tone, they report opposition accusations that the move to close the plant was little more than a campaign promise, and that the cost to shut down the plant will only increase with every day that construction continues ("Something's cooking; Liberals promised to close gas plant – but generator's arrival suggests otherwise", Toronto Sun, October 25, 2011; "Plant cancelled, but not work", Toronto Star, October 25, 2011).

As of October 24, at least 25 tweets referenced the news that construction is ongoing at Mississauga's proposed Greenfield South gas-fired power plant. Most link to the <u>Toronto Star</u> story "Full steam ahead at cancelled Mississauga plant".

 Devani wrote, "To all the idiots who voted McGuinty this is what you get...LMFAO, that didn't take long!!"

 the role TransCanada plays and as the government finalizes its LTEP we expect that
 TransCanada will continue to play an important role.

IF ASKED ABOUT HEALTH AND SAFETY

We have not stopped the plant because of health and safety concerns. Modern natural
gas plants are proven to be clean and safe. The main reason we are not moving ahead
with the construction of this plant is because circumstances have changed and we no
longer need the power it would have provided to ensure local system reliability. The
need for reliability continues to exist and we believe this can be met with a
transmission solution.

IF ASKED ABOUT LOCATING A GAS PLANT IN NANTICOKE INSTEAD OF THE SWGTA:

There are a number of alternative ways of meeting the energy needs that would have been supplied by the Oakville Plant. We are in the process of examining those alternatives through our Long Term Energy Planning process.

We are in an excellent supply situation in Ontario. The OPA will examine what options are available, including transmission options, to ensure reliability over the long-term.

The Greenfield South plant was not intended to operate continuously. It was designed to complement our baseload supply and operate only when electricity supply is needed, during periods of higher demand and to improve the reliability of supply to the local community.

The plant will not be called on to run at other times.

How often will the new plant operate?

Actual operation of the <u>an alternate natural gas</u> plant will depend on several factors including weather, <u>local system conditions</u>, demands on the electricity system and availability of other sources of power.

Greenfield was expected to operate about 10% to 45% of the time. Natural gas plants supplement power from other sources of supply including nuclear, water, wind and solar and support local reliability.

So we know for sure it will be a gas plant – and not additional transmission or other resources, such as renewable energy and conservation – that will replace this plant?

We are in an excellent supply situation in Ontario. The OPA will examine what options are available including transmission options to ensure reliability over the long-term.

The OPA will be exploring options.

The Greenfield plant was intended to operate only during times when it was needed—when demand is high and supply from hydro, wind, solar and nuclear is not enough, or when needed for local reliability.

Natural gas plants can be controlled and relied on to provide supply when it is needed. Natural gas complements the supply from renewable resources like wind and solar.

What about the transmission solution? When the Oakville plant was cancelled you said a transmission solution can ensure the area will have enough electricity.

We are in an excellent supply situation in Ontario. The OPA will examine what options are available including transmission options to ensure reliability over the long-term.

The Greenfield South plant won't operate continuously. It is designed to operate only when electricity supply is needed, during periods of higher demand and for local reliability. This will improve the reliability of supply to the local community and to the larger electricity system.

In addition to this small plant, a transmission solution is also required to help maintain a reliable and secure supply of electricity in the Oakville, Mississauga and the west GTA. Reinforcement of the bulk transmission system in the western GTA, particularly in the Milton area, is also still required.

Will a natural gas plant be built in the Kitchener-Waterloo-Cambridge-Guelph area? As indicated in the Long-Term Energy Plan the procurement of a natural gas plant in the Kitchener-Waterloo-Cambridge area is necessary.

The Kitchener-Waterloo-Cambridge area is a major automotive and high-tech centre and is experiencing rapid population and economic growth. Peak demand has been increasing at a rate double the provincial average. The region is host to several data centres that require a reliable power supply.

How many natural gas plants are there already operating in the GTA?

There are four major plants:

- The 550-megawatt Portlands Energy Centre near downtown Toronto
- The 874-megawatt Goreway Station in Brampton
- The 683-megawatt Halton Hills Generating Station
- A 117-megawatt cogeneration plant at the Toronto International Airport in Mississauga

In addition there are a number of smaller natural gas generating plants operating in industry, and in commercial and institutional complexes, including universities and hospitals, including:

- A 68-megawatt facility at the Ottawa Health Sciences Centre
- A 6.6-megawatt facility at Brock University in St. Catherines
- A 2.3-megawatt district energy facility at <u>Durham College in Oshawa</u>
- A 12-megawatt cogeneration facility in London
- A 5-megawatt cogeneration facility in Sudbury
- A 6.7-megawatt cogeneration facility at Sudbury hospital

WHAT RELOCATING GREENFIELD MEANS FOR OTHER PROJECTS

Are there other power projects set to break ground that you may reconsider?

What is the status of negotiations with TransCanada over the cancellation of the Oakville plant?

We are in discussions with TransCanada, and do not have an update at this time.

GENERAL BACKGROUND

- Greenfield South Generating Station is a 280-megawatt combined cycle natural gas
 plant located in the City of Mississauga on a 4.5 hectare property at 2315 Loreland
 Avenue. The plant will occupy roughly 2 hectares of the property. Part of the
 property will be dedicated to the city as a park.
- The plant is, 700 metres from the Trillium Health Centre and 1.1 km from the nearest school (Isna Elementary School). The nearest block of homes is about 250 metres south of the site.
 - The plant was selected in the Ministry of Energy Clean Energy Supply competition in 2005 and holds a contract with the Ontario Power Authority (OPA).
 - The plant's original planned commercial operation date was 2009.
 - Approval delays resulting from City of Mississauga opposition to the project at the
 environmental approval and building permitting stages harmed the economic viability
 of the project. The contract between Greenfield South Power Corporation and the
 OPA was renegotiated, and the commercial operation date has been extended to
 the third guarter of 2014.
 - The project obtained zoning approval in 2007 and environmental approval in 2008.
 - The OPA was advised on May 31, 2011 that the company has received its building permit for the plant. The company is moving equipment to the site, and excavation and foundation work is expected to start in early July.
 - The site is located in a predominantly industrial area. It is bounded by a railway line, a transmission corridor and the Queen Elizabeth Way.
 - The Ontario Municipal Board reviewed municipal planning and zoning and determined that the site was properly zoned and suitable for this type of electricity generation facility.
 - In October, 2011, the Minister of Energy wrote to the OPA asking them to begin discussions with Eastern Power to find an alternate location for the Greenfield South Plant.

Note:

In April 2005 Eastern Power was awarded contracts for two 280 MW natural gas plants – one for Greenfield South and one for Greenfield North (Hurontario St. north of Derry Road). In August 2005 Greenfield North contract terminated under a mutual agreement between the OPA and Eastern Power because Eastern Power was not able to obtain financing. The Greenfield South contract remained in place. At the time, Eastern Power said it preferred the Greenfield South site

because it was better for natural gas supply and electrical connection and the area was zoned for industrial activity, including power generation.

Hi Paul,

The announcement was about a few small investments being announced later today to create/protect 1600 jobs in the province.

In the Q&A, Minister Duguid was asked about the power plant in Mississauga, to which he replied that the government will be moving forward and ensuring the plant will be moved. He said he is no longer the Minister of Energy and that Minister Bentley handling it from now on.

He was also asked if moving the plant would send bad signals to companies considering investing in the province, if the government can cancel a contract on a whim. Duguid said you would be hard pressed to find a jurisdiction that has been as strategic and that the private sector sees Ontario has a great place to invest, including in the energy sector. He said the government has made the investments previous governments hadn't and the investments needed to build a clean reliable energy system.
